



Signs of Spring Competition

1. **Entrants**

- 1.1 All permanent residents of South Africa may enter.
- 1.2 Directors, members, partners, agents, consultants, tenants or employees of WWF-SA their immediate family members are not eligible to enter this competition.

2. **Term**

- 2.1 The competition shall be run from 3rd until 10th September, with winners to be announced on the 11th **September 2018**

3. **Entries**

- 3.1 Participants will be directed via promotional posts on WWF-SA's Facebook and Instagram accounts to the [ForNature.ForYou](#) microsite where they will be able to create a picture to celebrate spring. They will be required to share their creations on their private social media accounts while using the competition hashtags #fornatureforyou and #SignsofSpring as communicated via the promotional posts and tagging WWF South Africa. Once the submission window closes, WWF's digital team will select the top three images and ask supporters to vote for their favourite pictures on Twitter and Instagram. The poster with the picture with the highest number of votes will win the prize.
 - 3.1.1 Images shall be selected by the WWF-SA digital manager based on the quality of the image submitted and whether it best exhibits signs of spring. Pictures of nature shall receive a greater preference.
 - 3.1.2 For a picture to be eligible, the sender must either own or have taken the image themselves or must have the right to the image.
 - 3.1.3 The decision of the WWF-SA digital manager shall be final and no correspondence shall be entered into about the decision.
- 3.2 By entering the competition the entrant agrees to allow WWF-SA to use the image which they posted to enter the competition on social media and in future marketing campaigns provided that WWF-SA shall at all times acknowledge the owner of the image.
- 3.3 The entrant indemnifies WWF-SA against any claims whatsoever by a third party relating to the images submitted, including claims relating to infringement of intellectual property. By posting the image the entrant warrants that he/she has the authority and right to use the images.
- 3.4 WWF-SA takes no responsibility for any inability of an entrant to enter, complete, continue or conclude the competition due to equipment or technical malfunction, busy lines, inadvertent disconnection or otherwise.

- 3.5 By entering this competition the entrant accepts the full terms, conditions and rules of this competition and agrees to abide by these rules and any requirements and/or proceedings issued by WWF-SA in regard to the competition.

4. The Prize

- 4.1 The winners of the draw will be eligible to win a Panda toy valued at R200
- 4.2 In relation to the Prize, postage to the entrant's given address is included, provided such address is in South Africa.
- 4.3 In the event that any of the Prize specified in the Competition becomes unavailable for any reason, WWF-SA may substitute a Prize of like or equal value.

5. The Winner

- 5.1 The Prize will be awarded to the entrant who received the most social media votes who has met the requirements of the competition, and the Winner will be notified by WWF-SA via email/phone call within one month of the Prize draw. The results of the competition will be verified by an independent competition auditor.
- 5.2 The Winner accepts the Prize entirely at his/her own risk and indemnifies WWF-SA in respect of any claim for any accident, injury, or property damage that may occur in connection with the Prize to the fullest extent allowed by law.
- 5.3 The Prize is neither transferable nor exchangeable for cash or another Prize, and must be accepted by the Winner within **one month** of winning the Prize or he/she will forfeit the Prize.
- 5.4 The Winner may be requested to be photographed and interviewed by the promoters and have his/her name published in promoter correspondence.
- 5.5 Where a diligent attempt to contact the Winner fails or the winner elects not to take the Prize or is unable to take the Prize for whatever reason WWF-SA reserves the right to either select another Winner or not award a Prize at all, in its sole discretion.
- 5.6 If, after successful notification, the Prize is not collected within one month of being announced it will be regarded as forfeit.

6. The Promoter

- 6.1 WWF-SA reserves the right, at any time, to verify the validity of an entry and to refuse the entry of any person who submits an entry that is not in accordance with these terms and conditions or who tampers with any process in redeeming the Prize.
